

Privacy Policy

The privacy policy of personal information (hereinafter the "Policy") is valid in relation to all information that Matrix LLC and / or its affiliates persons, including all persons belonging to one group of Matrix LLC (hereinafter "Matrix LLC"), can receive about the User during the use of any of the sites, services, services, programs, products or services of Matrix LLC (hereinafter referred to as the "Services") and during the execution of any agreements and contracts with the User by Matrix LLC. Use of Matrix LLC Services means the unconditional consent of the User with this Policy and the conditions for processing his personal information; in case of disagreement with these conditions, the User must refrain from using the Services.

1. Personal information of Users, which is processed by Matrix LLC

- 1.1. Within the framework of this Policy, under the "personal information of the User" are understood:
- 1.1.1. Personal information that the User provides about himself independently when registering (creating an account) or in the process of using Services, including the User's personal data. Required to provide Services information is marked in a special way. Other information is provided by the user at his discretion.
 - 1.1.2. Data that is automatically transmitted to the Services in the course of their use with using the software installed on the User's device.
 - 1.1.3. Other information about the User, the processing of which is provided for by the conditions use of certain services.
- 1.2. This Policy applies only to information processed during use of Matrix LLC services.

2. Purposes of processing personal information of Users

- 2.1. Matrix LLC collects and stores only that personal information that is necessary for the provision of Services or the execution of agreements and contracts with by the User, except for cases when the legislation provides mandatory storage of personal information for a period specified by law.
- 2.2. Matrix LLC processes the User's personal information in the following purposes:
- 2.2.1. Identification of the party within the framework of the Services, agreements and contracts with Matrix LLC;
 - 2.2.2. Providing the User with personalized Services and execution agreements and contracts;
 - 2.2.3. Communication with the User, including sending notifications, requests and information regarding the use of the Services, the execution of agreements and contracts, and also processing requests and applications from the User;
 - 2.2.4. Improving the quality of the Services, ease of use, development of new Services.

3. Conditions for the processing of personal information of Users and its transfers to third parties

- 3.1. Matrix LLC stores personal information of Users in accordance with internal regulations of specific services.
- 3.2. In relation to the User's personal information, it is stored confidentially, except in cases of voluntary provision by the User information about yourself for general access to an unlimited number of persons.
- 3.3. Matrix LLC has the right to transfer the User's personal information to third persons in the following cases:
- 3.3.1. The user has consented to such actions;
 - 3.3.2. The transfer is necessary for the User to use a certain Service or for the performance of a specific agreement or contract with the User;
 - 3.3.3. The transfer is provided for by Azerbaijan or other applicable law within the procedure established by law;
 - 3.3.4. Such a transfer occurs as part of a sale or other transfer of business (completely or in part), with all obligations to comply with the terms of this Policy in relation to the personal information received by him;
 - 3.3.5. In order to ensure the possibility of protecting the rights and legitimate interests of Matrix LLC third parties in cases where the User violates the User Agreement Matrix LLC services, this Policy, or documents containing the terms use of specific Services.
 - 3.3.6. When processing personal data of Users, Matrix LLC is guided by Law of the Azerbaijan Republic "On Personal Data".

4. Measures used to protect user personal information

- 4.1. Matrix LLC accepts the necessary and sufficient organizational and technical measures to protect the User's personal information from unauthorized or accidental access, destruction, modification, blocking, copying, distribution, as well as from other illegal actions with it by third persons.

5. Changes to the Privacy Policy

- 5.1. Matrix LLC has the right to make changes to this Policy confidentiality. When changes are made in the current edition, the date is indicated last update.
